Bakshi had given his affidavit and undertaking that the shares held by him in CPIL will not be alienated or transferred," said HUDCO while annexing copy of Bakshi's affidavit in its petition filed before the NCLAT.

Passing the judgement, the DRT had on August 12, 2015 issued recovery certificate favour of HUDCO to recover the sum along with 14 per cent interest from Ascot Hotel Vikram Bakshi, Madhuri Bakshi and Vikram Bakshi Co Ltd.

Thereafter, respondent, including Bakshi, was asked to disclose their details of movable and immovable asset. However, on their repeated failure to do so, HUDCO moved the DRT again for attachment of their bank account and 3,100 shares held by Bakshi in CPIL.

On this, DRT had on February 2, 2016 issued "interim directions restraining Vikram Bakshi from alienating or transferring or creating any third party interest in the 3,100 shares of CPIL or any other quantity in the name of Vikram Bakshi till further orders."

Last week, when HUDCO came to know about the settlement between Bakshi and
