We would like to inform you that pursuant to Section 192A of the Companies Act, 1956 read with Companies (passing of the resolution by postal ballot) Rules, 2011, the Company had dispatched Postal Ballot notice dated 10 February 2014 to its all equity shareholders and as well as preference shareholder who is entitled to vote as per Section 87 of Companies Act, 1956 along with draft resolution and explanatory statement with respect to special business contained in the said notice.

The Board of Directors of the Company had appointed Mr Vinay Kohli, partner, M/s K K Kapoor and Associates, Chartered Accounts as Scrutinizer to conduct the postal ballot process in a fair and transparent manner. The last date for receipt of responses from the shareholders by the scrutinizer was fixed as 18 March 2014, till the close of working hours of the day. After completion of the scrutiny, the Scrutinizer has submitted his report to the Director (Works) of the Company. The results of the postal ballot were announced on 19 March 2014 at the registered office of the Company. According to the postal ballot results, the resolution for extension of date of redemption of preference shares with an option to convert these shares into equity shares has been passed as special resolution with 99.995% majority on 19 March 2014.
